

## **Marine Eco-Label Japan Council Membership Regulations**

### Article 1. General Rules

These Regulations set forth necessary matters concerning the admission to and withdrawal from membership in the Marine Eco-Label Japan Council (the “MEL Council” hereinafter) and the membership fees pursuant to the provisions of Chapter 3 of the Statutes of the Marine Eco-Label Japan Council.

### Article 2. Membership Qualifications

1. Parties who support the purpose of the MEL Council and wish to join the MEL Council must make an application in accordance with the procedures set forth by the Board of Directors and obtain its approval.
2. Membership application requires nomination by at least one officer of the MEL Council.
3. Members must be a corporation under the laws of the relevant country or region.
4. Members shall notify changes to its name, address, or the name of representative, etc. without delay.

### Article 3. Enrolment Fee and Membership Fee

1. Members must pay the following Enrolment Fee when they join, and an annual Membership Fee to be applied to the ordinary expenses for business activities of the MEL Council.

1.1 Full Member: Minimum of fifty-thousand yen per membership

1.2 Supporting Member: Minimum of twenty-thousand yen per membership

2. If a new member joins in the middle of a business year and its membership is approved in the second half of the year (from October to March of the following year), its membership fee for that business year will be half the annual fee.

### Article 4. Voluntary Withdrawal

Members may voluntarily withdraw from membership by submitting a withdrawal notice pursuant to procedures set forth by the Board of Directors. Provided, however, membership fees already paid will not be refunded.

### Supplementary Provisions

These Regulations shall become effective as of December 1, 2016.

These Regulations shall become effective as of November 25, 2024.
